# **Lifetime Active Growth Fund**

### What is the purpose of this update?

This document tells you how the Lifetime Active Growth Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Lifetime Active Growth Fund aims to provide annual returns of 10% after the base fund fee\* but before tax and before the performance fee, over the minimum recommended investment timeframe. The Fund invests primarily in equities, with a moderate allocation to fixed interest securities.

#### What are the risks of investing?

#### **Risk indicator for the Lifetime Active Growth Fund**



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


The market index annual return for the Fund is a composite index, calculated using the return of each asset class index the Fund invests in, weighted by the Fund's benchmark asset allocation.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$1,593.59 (that is 15.94% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$1,593.59 for the year.

# What does the fund invest in?


### Actual investment mix
